If the application ceases for any reason we keep hold of the details for six months just in case the applicant would like to explore other avenues or properties, after all no-one like re-filling forms time and again!

We may need to pass certain details about you to other people and companies - this includes the landlord or the letting agents, Equifax for your credit check and your employer/accountant (if applicable) to confirm your employment.

You also have a right to lodge a complaint with the ICO if you wish.

## Use of information provided by You

- Vouch is a Data Controller as defined in the Data Protection Act 1998.
- In order to verify the contents of the Application, Vouch will need to share Personal Data with third parties and the Landlord and/or Letting Agent. Where it is necessary to do so, Vouch will comply with all aspects of the Data Protection Act 1998.
- Vouch's data protection policy which is available at [www.vouch.co.uk](http://www.vouch.co.uk) is incorporated into these terms and conditions.
- Should it be necessary for Vouch to transfer Personal Data overseas, this information will only be shared within the EEA. Any such transfers will be made in full compliance with the Data Protection Act 1998.
- In order to complete the Application, Vouch will consult with a number of sources to verify the information that You provide. We will never share your data with anyone other than for the purposes of verifying the suitability of your application to be a guarantor. The third parties with whom it may be necessary for Vouch to share information relating to your Application may include but are not limited to:

  - financial organisations;
  - credit reference agencies;
