


Properties can be let if they have an energy rating from A to E.

## **Energy rating and score**

## How this affects your energy bills

An average household would need to spend £784 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

#### **Step 1: Floor insulation (solid floor)**

#### Step 4: Solar photovoltaic panels, 2.5 kWp
