
Properties can be let if they have an energy rating from A to E.

Energy rating and score

Low and zero carbon energy sources

Primary energy use

The primary energy use for this property per year is 437 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

4. Replacement glazing units	£1,000 - £1,400	£64
5. Solar photovoltaic panels	£5,000 - £8,000	£301
